- ➤ The Recent Developments column has been discontinued due to lack of submissions.
- > Our web developer, Jason Robinson, will now be preparing and placing the journal issue on the web. I very much appreciate his skills in this area and look forward to working with him in this capacity. Thank you, Jason.
- ➤ Plans are in the works to add a section to the journal for job postings in the area of Family and Consumer Sciences. We will pilot this section during the 2004 year and evaluate it at the end of 2004.
- > Plans are also in the works to add a section to the journal for professional events to be listed for society meetings, etc. This pilot will be evaluated at the end of 2004.
- ➤ I am also looking into sponsorship for the journal to defray some of the management costs of *FFCI*.
- > The journal will no longer list Past Editorial Board Members' names, however we do appreciate their former service to this journal.
- > The journal will now be issued three times a year instead of four. Due dates for submissions effective immediately are January 1, May 1 and September 1 to accommodate a Spring, a Summer, and a Fall/Winter issue, respectively.
